11. TO CONSIDER PLANNING ISSUES

a) To discuss any planning applications received

2025-1654 Development at the site of The Bungalow, Norwich Road, Tuttington – amended plans

Many of the Parish Councils original objections were not considered valid. The soakaway needs clearing and this may alleviate the flooding issues. Would support solar panels.

b) To discuss decision re 2024/1616 Land Adjacent to 18 Aylsham Road, Tuttington

This application was called in as the site is outside the boundary limits. The Parish Council were concerned over the visibility splay requirements but this is not considered a material matter and is up to the developer to negotiate. Approval was based on the splay requirements being a condition and it was also stated this would not create a precedent.

c) To discuss any other planning applications received

The Parish Council have reported the situation on Aylsham Road and the enforcement team at Broadland are taking action.
